TO: INTENDING MEMBER:

- 1. Please ensure that this form is filled out clearly so that our records can be maintained accurately.
- 2. Under the Club's Constitution the application must be posted on the notice board for at least 7 days and then then is considered at the routine Board of management Meeting held on the second Tuesday of each month.
- 3. In the interim, you are entitled and are most welcomed to use all Club facilities, including competition play whilst the application is being assessed.
 - Note, competition trophies cannot be won until membership is accepted and subscription paid.
- 4. Membership is an <u>ANNUAL SUBSCRIPTION</u> and you are liable for the full annual membership fee. This fee may be paid in one of three alternate ways:
 - Full once off payment.
 - Direct Debit Payment on a monthly basis from a bank account a monthly fee is applicable.
 - Split the complete year into two moiety payments a bi-annual fee is applicable.
- 5. Payment of the subscription fee on application saves the Club considerable work and is greatly appreciated. If your application is unsuccessful, all money paid will be fully refunded.
- 6. Upon acceptance of your nomination, if payment was not made on application, you will receive an account for your annual subscription which must be paid within 14 days.
- 7. If you wish to resign from the Club, you are required to do so in writing. Membership is an **ANNUAL SUBSCRIPTION** and you are liable for the full annual membership fee. Therefore, as applicable:
 - You will not be eligible for refund of fees paid,
 - You will not be released from payment of any subscriptions of arrears,
 - You will not be released from payment of the second moiety or direct debit payments which shall be due by you to meet the annual subscription of that year.
- 8. New members are placed on a three month probation period from the date of acceptance by the Board. Any breach of club rules, etiquette or any misbehaviour during this time could see your membership revoked.
